

We start the new year with our first CPD (Continuing Professional Development) with Chris Harris

Chris is the National HSE Manager – Technical, for Downer

Chris has sent me the following outline on his talk: -

It's important to acknowledge that I'm not qualified in occupational hygiene or occupational health – but I've had input from a hygienist and an occupational physician.

The purpose of what I've produced is a tool to help generalists:

- 1. Consider what the occupational health hazards are in their business
- 2. Define the key controls that they (as generalists) should be looking for when assessing work
- 3. Setting expectations for pre-employment and ongoing health assessments (this detail should be checked with occupational health practitioner)
- 4. Engaging with an occupational hygienist to develop monitoring programmes (workplace and worker exposures) and
- 5. Identifying their SEGs (similar exposure groups) for monitoring and assessments

It is still a work-in-progress, but I'm keen to share it with a wider group because it's likely there will be people in the group who do have expertise and so could provide useful input.

I'm sure we are all going to learn something from this talk

AGM - 14.06.23


We have set the date for our annual AGM to be held on 14.06.23.
