OVERLAPPING DUTIES – by Andrew Saunders


Both contracting and contracted PCBUs often fail to answer the simple question: "who is responsible for contacting Worksafe NZ in the case of a notifiable incident". This fundamental duty remains either unresolved or misunderstood.

It is important that PCBU sharing a site resolve each parties duties <u>before</u> beginning work.

The extent of each PCBU's responsibility to carry out their duties will depend on what ability the PCBU has to influence and control the health and safety matter. Typically, the more influence and control a PCBU has over a health and safety matter, the more responsibility it is likely to have. A PCBU can have influence and control over health and safety matters through:

- Control over the work activity
- Control of the workplace; and/or
- Control over workers.

A PCBU with a higher level of influence and control will usually be in the best position to manage the associated risks. The PCBU with less control or influence may fulfil their responsibilities by making arrangements with the PCBU with the higher level of influence and control. It is important these arrangements are documented, communicated, understood, and agreed.



Despite the sharing of duties, all PCBUs still retain the responsibility to meet their duties. They must monitor each other to ensure everyone is doing what they agreed. They must intervene if they identify an uncontrolled hazard or risk and resolve it before continuing with the work.

Note that the size of a PCBU or its financial resources does not equal its ability to have control or influence over health and safety matters. The PCBU with the most financial resources does not automatically have most of the responsibilities.

Please remember your Northland Branch committee is working hard for you to continue providing quality speakers and events as a part of your membership. There is also a lot of work that goes on in behind the scenes. Efforts put in are purely voluntary and it is vital the branch is supported.
